**THE OFFICE OF ATTORNEY GENERAL'S AMICUS CURIAE ADVISORY AND  
MOTION TO SEAL THE LAST KNOWN ADDRESSES OF DEFENDANTS POLLOCK,  
WILLIFORD, GLAZE AND HILL**

The Office of the Attorney General ("OAG") files this *Amicus Curiae* Motion and Advisory as follows:

**I. ADVISORY**

On February 5, 2020, the Court ordered Defendants Brandon K. Pollock, Zachary H. Williford, Sylvester Glaze, Jr., Michael Hill and V.A. McMillian to file an answer to Plaintiff's claims. On March 27, 2020, Defendant V.A. McMillian appeared and filed a motion to dismiss. The remaining defendants are now former employees of the Texas Department of Criminal Justice and no longer work at a TDCJ facility. To date, the OAG has not been able to contact Pollock, Williford, Glaze or Hill, and has not received a waiver of citation or request for representation from any of them. Therefore, the Office of Attorney General is without authority at this time to represent these Defendants, and no answer or responsive pleading has been filed on their behalf.

**II. MOTION TO SEAL**

The Office of the Attorney General requests that Brandon K. Pollock, Zachary H. Williford, Sylvester Glaze, Jr., Michael Hill's last known addresses be sealed and that such information not be revealed to the Plaintiff. Personal identifying information, including home addresses and telephone numbers of employees or ex-employees of the Texas Department of Criminal Justice and their

families, is confidential. Tex. Civ. Prac. & Rem. Code §30.010(a); Omnibus Consolidated and Emergency Supplemental Appropriations Act, 1999, Pub. L. No. 105-277, § 127(2), 112 Stat. 2681. Release of such information is a criminal offense. Tex. Gov't. Code Ann. § 552.352.

The Office of the Attorney General requests that should such information be included in any document or used in order to attempt service, any reference to the last known addresses of Brandon K. Pollock, Zachary H. Williford, Sylvester Glaze, Jr., Michael Hill be redacted on the copy sent to Plaintiff. A copy of this motion is being provided to Plaintiff with the personal identifying information redacted from **“Exhibit A.”**
